## DOG REGISTRATION AND POUND FEES – 2016/2017

**SEE UNDER FOR IMPORTANT NOTES:**

### **NOTES:**

1. All dogs **must be registered to an individual person** of or over the age of 16 years and **NOT to a partnership or company name.**
2. All rebates are applied as a percentage of the full registration fee and the Pensioner concession of 50% is applied after the “normal” registration fee has been determined.
3. **New** dog registration applications on or after the 1st of January in any year shall be discounted to 50% of the full fee.
4. The above discount structure **does not** apply to any re registration applications. These **must** pay the applicable full fee together with a late fee if paying after 31<sup>st</sup> August in any year.
5. An impounded dog, if not claimed within 72 hours, becomes Council property to be disposed of as Council sees fit. If pound fees remain unpaid for more than 7 days after a request for payment has been made, the dog/s become Council property to dispose of as Council sees fit and legal action may occur to recover costs.
6. All pound fees **MUST be paid before the release** of any impounded dog. If the dog/s is/are unregistered, they **MUST be registered before they are released.**
7. **Pound fees:** \$55 Impounding fee plus \$27.50 holding fee per day. (e.g. 3 days is 55.00+82.50 = \$137.50)
8. **Voluntary surrender:** Council is under no obligation to pick up dogs in this category however, if it does occur, it will be on the basis of cost recovery; i.e. \$160 flat rate plus \$70 per additional dog being surrendered by the same individual.
9. If dogs are surrendered direct to RSPCA or AWL there will be charges. Contact respective organisations to enquire.
