	3.6.4.3 is the trustee of a person referred to in Section 92(5)(i) or (ii) of the Act or is managing the affairs of such a person on some other basis; and		
	3.6.5 stating the purpose for which the notice is issued and giving notice of the requirement or the risk to which it relates; and		
	3.6.6 imposing any requirement reasonably required for the purpose for which the notice is issued including 1 or more of the following:		
	3.6.6.1 a requirement that the person discontinue, or not commence, a specified activity indefinitely or for a specified period or until further notice from a relevant authority;		
	3.6.6.2 a requirement that the person not carry on a specified activity except at specified times or subject to specified conditions;		
	3.6.6.3 a requirement that the person take specified action in a specified way, and within a specified period or at specified times or in specified circumstances;

	3.6.6.8 a requirement that the person prepare, in accordance with specified requirements and to the satisfaction of the relevant authority, a plan of action to secure compliance with a relevant requirement or to prevent, eliminate, minimise or control any specified risk to public health;
