- Provide the address or description of any land in which you have or a designated person or entity in relation to you<sup>3</sup> has any beneficial interest<sup>7</sup> other than by way of security for any debt.
- Provide details of any fund in which you or a designated person or entity in relation to you<sup>3</sup> has an actual or prospective interest to which contributions are made by a person other than you or a designated person or entity in relation to you<sup>3</sup>.
- 9 If you are or a designated person or entity in relation to you<sup>3</sup> is indebted to another person (not being your relative<sup>8</sup> or a relative<sup>8</sup> of a member of your family<sup>4</sup>) in an amount of or exceeding \$7 500—state the name and address of that other person.
- 10 If you are or a designated person or entity in relation to you<sup>3</sup> is owed money by a natural person (not being your relative<sup>8</sup> or a relative<sup>8</sup> of a member of your family<sup>4</sup>) in an amount of or exceeding \$10 000—state that person.
- Declare any other substantial interest of yours or of a designated person or entity in relation to you<sup>3</sup> whether of a pecuniary nature or not, of which you are aware and which you consider might appear to raise a material conflict between your private interest and the public duty that you have or may subsequently have as a member of the council.
- 12 Provide any other additional information which you think fit.
