



NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Garreth Lee Jones, Acting Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act.

I declare that the '**2024 Rally of the Heartland**' is an event to which this section applies and that the following roads be closed to traffic between the listed times and dates below:

Within the Northern Areas Council and Regional Council of Goyder: -

- **Bridge Terrace** between Kingston Street and Paxton Road
Between 10.00am on Thursday 25 April 2024 and 10.00am on Monday 29 April 2024

Ride Day

- **West Terrace** between Peacocks Chimney to the Heritage Area gates and the lookouts
- **The access road to the Burra Council dump** from the junction with the Barrier Highway to the entrance to the dump proper
Between 6.00am and 10.30am on Friday 26 April 2024

SS 1 & 5 – Prologue 1

- **Hallelujah Hills Road** from World End Highway and Koo-Owie Gap Road.
Between 10:00am to 6:00pm on Friday 26th April 2024

SS 2 & 6 – Prologue 2

- **Dunstone Road** between Ngapala Road and Scenic Road.
- **Scenic Road** between Dunstone Road and Garden Road.
- **Garden Road** between Scenic Road and Ngapala Road
- **Ngapala Road** between Garden Road and Brady Road
- **Brady Road** between Ngapala Road and a point 1.4 km West of Neindorf Road.
Between 10:15am to 6:30pm on Friday 26th April 2024

SS 3 & 7 – Prologue 3

- **Julia Road** between a point 700m South of Milde Road and Mosey Road.
- **Mosey Road** between Julia Road and Scenic Road.
- **Scenic Road** between Mosey Road and Cutting Road
- **Cutting Road** between Scenic Road and Worlds End Highway.
Between 10:45am to 7:00pm on Friday 26th April 2024

SS 4 and SS 8 – Prologue 4

- **Powerline Road** between a point 3 km East of Worlds End Hwy and Eagle Hawke Gate Road.
- **Eagle Hawke Gate Road** between Powerline Road and Thomas Road.
- **Thomas Road** between Worlds End Highway and Eagle Hawke Gate Road.
Between 11:00am to 7:30pm on Friday 26th April 2024

SS 9 and SS 12 – Box Creek

- **Clay Road** between Barrier Highway and Pidgeon Box Road.
- **Pidgeon Box Road** between Clay Road and Uloomoo Road.
- **Uloomoo Road** between Pidgeon Box Road and Uloomoo Station entrance.
Between 4:30pm to 10:00pm on Friday 26th April 2024 and between 10:15am to 4:00pm on Saturday 27th April 2024.

SS 10 & 13 & 15 & 19– Route 21 and Route 12

- **Mount Bryan East Road** between Scrub Road and Banbury Road.
- **Banbury Road** between Mount Bryan East Road and Glen View Road.
- **Glen View Road** between Banbury Road and Mount Bryan East Road.
- **Mount Bryan East Road** between Glen View Road and Wilkens Drive.
- **Mount Bryan East Road** between Wilkens Road and Dares Hill Summit Road.
- **Mount Bryan East Road** between Dares Hill Summit Road and Dare Road.
- **Dare Road** between Mount Bryan East Road and Dust Hole Creek Road.
- **Dust Hole Creek Road** between Dare Road and Dares Hill Summit Road.
- **Dares Hill Summit Road** between Dust Hole Creek Road and Mallett Road.
- **Mallett Road** between Dares Hill Summit Road and Ragless Road.
- **Ragless Road** between Mallett Road and Scrub Road.
- **Scrub Road** between Ragless Road and Banbury Road.
Between 4:30pm to 11:45pm Friday 26th April 2024, between 10:30am to 10:15pm and Saturday 27th April 2024 and between 10:00am to 5:15pm on Sunday 28th April 2024

SS 11 and SS 14 – Mount Bryan

- **White Field Road** between Mount Bryan East Road and Dust Hole Creek Road.
- **Dust Hole Creek Road** between White Field Road and White Hill Road.
- **White Hill Road** between Dust Hole Creek Road and Old Belcunda/Newikie Road.
- **Old Belcunda/Newikie Road** for 500m North from White Hill Road.
Between 8:30am to 7:00pm on Saturday 27th April 2024

SS 17 – Mongolata

- **Caroona Road** from a point 800m south of White Hill Road until White Hill Road.
- **White Hill Road** between Mount Bryan East Road and Caroona Road.
- **White Hill Road** between Dust Hole Creek Road and Old Belcunda/Newikie Road.
- **Old Belcunda/Newikie Road** for 500m North from White Hill Road.
Between 7:45am to 2:00pm on Sunday 28th April 2024

SS 15 & 18 & 20 – Diesel and Dust

- **Belcunda Road** between Kolinda Road and Lines Road.
- **Belcunda Road** between Lines Road and Cobb & Co Road.
- **Cobb & Co Road** between Belcunda Road and West Terrace.
- **West Terrace** between Cobb & Co Road and Tregony Street.
- **Tregony Street** between West Terrace and Hampton Road.
Between 1:45pm to 7:15pm on Saturday 27th April 2024 and between 8:45am to 2:30pm on Sunday 28th April 2024

I direct that competitors and officials taking part in the ‘**2024 Rally of the Heartland**’ be exempted, in relation to a road on which the event is to be held, from the duty to observe any enactment, regulation or by-law prescribing a rule to be observed on roads by drivers of vehicles.

I further direct that the event must comply with the following:

- Comply with all Motorsport Australia requirements
- All closures must be conducted by personnel with the appropriate Work Zone Traffic Management training and utilising approved signage.
- All vehicles participating must be registered and road worthy
- All participants must hold appropriate drivers licence and not be disqualified from driving or form holding a licence in any State or Territory.
- Participants are not exempt from RTA offences related to drink and drug driving.

I also hereby authorise **Rally SA**, or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

All works to be undertaken must be done so in accordance with the "**SA Standards for Workzone Traffic Management**" (which calls up the **Austrroads Guide to Temporary Traffic Management and AS1742.3**).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.
